MHB Fund Balance Report: An analysis of the MHB strategic effort to spend down reserves was presented. Over FY11 and FY12 HYB has used \$247,448 of reserve funds for capital projects and emergency, challenge, and capital grant. An additional \$188,500 of reserves is budgeted for FY13 grants. The report reflected the effect of delayed payments of tax revenues in fund balances where applicable.

Presentations of Grant Requests

Representatives of Renz Addiction Counseling Services arrived and presented the agency's request for emergency and Challenge Grant funding for the agency's ATOD prevention services. The requests were submitted after loss of state grant for prevention programming in the Hanover Township area.

Mr. Parquette, Youth and Family Services, presented a request for funding of the HTYFS Clinical Interventionist and explained the staff members proposed work with Positive Behavior Interventions and Supports (PBIS) program in the schools.

Challenge Grant Requests
