# Introduction

The Illinois Constitution allows for the creation of 708 boards through the Illinois Community Mental Health Act. In 1977, the voters of Hanover Township approved a referendum that established a community mental health board to levy an annual tax for the purpose of funding mental health, developmental disabilities, and substance abuse programs that serve residents. It is now known as the Hanover Township Mental Health Board. The Illinois Community Mental Health Act mandates that local mental health authorities not only administer local funds to ensure service provisions to its residents, but are responsible for planning and coordination of services within the local mental health system. The Hanover Township Supervisor, with the advice and consent of the Township Board of Trustees, appoints up to nine volunteers (eight community members and one Township Trustee liaison) to sit on the Mental Health Board and administer funds.

For the past 45 years the Mental Health Board has collaborated with area agencies serving Hanover Township residents to ensure programs and services are offered and the needs of the community are being met. The Mental Health Board continuously works with area agencies to develop a comprehensive and coordinated system of program delivery. Presently the Mental Health Board distributes approximately one million dollars in funds to 30 local agencies annually. Over 40 programs, serving over 5,000 Hanover Township residents, benefit from these funds.

The Mental Health Board distributes its mental health funding on an annual basis. Agencies apply each year and are awarded funding based on priorities established by the board and needs in the community. In Fiscal Year 2022, the Mental Health Board distributed \$965,000 mental health funds. The board also distributed over \$127,750 in additional funds (capital, program development, staff development and emergency funds) throughout the year. To address the needs of the developmentally or mentally disabled that have "aged out" of the school system, the Mental Health Board funds two transportation programs to facilitate disabled adults in maintaining daily living. These programs, and additional funded programs, were a result of previous three-year strategic plans approved by the board.

In addition to administering funds, the Community Mental Health Act requires that the Mental Health Board maintain an overall plan for delivery and operation of mental health services within the Township and its provider agencies. Every three years, the Mental Health Board reviews and evaluates needs in the community, changing trends, and gaps in services. The evaluation allows for the board to create a three-year strategic plan to establish measurable goals for services in the community.

For the Fiscal Years 2023 to 2025 strategic plan, the Mental Health Board used a multifaceted approach to review both qualitative and quantitative data for the Township. The Mental Health Board contracted with the Northern Illinois University Center for Governmental Studies to complete a community analysis, in addition to using secondary sources of information from the U.S. Census and statistics from established behavioral health research organizations like the National Institute for Mental Health to provide a better understanding of the Township population. Focus groups provided the qualitative data allowing residents to express concerns regarding needed services, service gaps, and experiences with local agencies. The following three-year plan provides a look at the needs of the community and the continued focus on providing residents with access to essential programs in the areas of mental health, substance abuse, and developmental disabilities.

# **Part I: Community Overview**

# **Township Profile**

Hanover Township is located approximately 35 miles northwest of the City of Chicago on the outer portion of Cook County. The Township is approximately 36 square miles and encompasses portions of six communities: Streamwood, Elgin, Bartlett, Hanover Park, Hoffman Estates, and Schaumburg. It also services unincorporated Cook County residents within these boundaries. As of 2020, the US Census reports Hanover Township with 100,092 residents.

## **General Population Needs and Trends**

## COVID-19

In January of 2020, the novel COVID-19 coronavirus hit the United States. This virus changed everyday life in the United States and around the world. Public action, such as social distancing and Stay-at-Home orders became necessary. It also had unintended consequences such as increased stress, isolation, loneliness, lack of care, and financial stress. Nearly every industry in the United States was affected, including the industries of Human Services. The need for mental health services became very clear early in the pandemic but the ability to meet the need under the current structure was lacking. The Substance Abuse and Mental Health Services Administration (SAMHSA) reports that 8% of Americans experienced a major depressive episode in 2019. That number jumped to 22% of Americans experiencing the same symptoms in May of 2021. SAMHSA also points out that every demographic measured is experiencing a spike in mental health needs, with young adults aged 18-29 the highest. With higher levels of stress and anxiety, the rate of substance abuse issues also rose. According to the CDC, 2020 saw an 18% increase in overdoses. In the field of developmental disability, many of these issues were compounded by the closure of day programs and the isolation of residential programs. The presence of a developmental or intellectual disability makes an individual six times more likely to die of COVID-19, according to the Association of American Medical Colleges. Many of these people also need constant care. T the workforce shortage, because of the pandemic, compounded the problem.

# **State Funding Changes**

In the area of mental health, Illinois has made some drastic changes to state law that will affect local agencies profoundly. The first is the passage of House Bill 2784. House Bill 2784 requires all Illinois municipalities to coordinate 911 dispatchers with the 988 line that provides access to mental health professionals. Dispatchers will contact mobile behavioral mental health services when deemed appropriate instead of law enforcement. Many local agencies are receiving funding from the state to provide these mobile mental health services. Secondly, House Bill 2595 passed and will require medically necessary mental health care to be covered by insurance companies beginning January 1, 2023. Many local agencies that receive funds from the Hanover Township Mental Health Board use their funds to cover underinsured clients.

In the area of developmental disabilities, Illinois has a long way to go. Currently, Illinois is ranked 47<sup>th</sup> out of 50 states in funding community-based services for people with developmental disabilities. The COVID-19 pandemic exasperated an already dire situation, with the turn-over rate of staff working in this field 54% higher than the average workforce. The average wage for these workers is \$12.34 per hour and Illinois is moving to a \$15 per hour minimum wage by 2025. The 2022 budget for Illinois increases the Department of Developmental Disabilities budget by \$329 million. Also, American Rescue Plan Act money has been allocated to community-based services. Still, local agencies that provide these services are finding themselves depending on fundraising and money from local sources.

During this period, Illinois also received and dedicated an additional \$92 million from the American Rescue Act Plan to fund substance abuse prevention and recovery services.

#### **Mental Health**

According to the National Alliance on Mental Illness (NAMI), an estimated 44.7 million, or just over 21%, of adults aged 18 or older had a mental, behavioral or emotional disorder in the past year. Over 26 million Americans received virtual mental health services in 2020. Fifty percent of those who received virtual services have been diagnosed with a Serious Mental Illness (SMI). An SMI is defined as having a mental, behavioral, or emotional disorder that substantially interferes with or limits one or more major life activities. NAMI states the most common serious mental health illnesses in the United States are major depressive disorder, anxiety schizophrenia, and bipolar disorder among others, such as obsessive-compulsive disorder, post-traumatic stress disorder, and personality disorders.

NAMI also reports approximately 1 in 6 youth, aged 6-17, experienced a major depressive episode in 2020. Many mental health disorders such as depression, anxiety and impulse control disorders emerge during adolescence. Children receiving family-based services are more likely to obtain treatment. Mental health experts continue to be concerned about the effect the COVID-19 pandemic has had on the mental health of both children and adults.

Mental health problems left untreated may lead to poor school performance, school dropout, and/or delinquency causing introduction to the juvenile justice system and substance abuse. An estimated 70% of youth in the juvenile justice system have a diagnosable mental health disorder. A 2014 survey completed by the Substance Abuse and Mental Health Services Administration (SAMHSA) reflects an increase each year of youths, ages 12 to 17, having major depressive episodes, with and without severe impairment. Illinois rates tend to be slightly higher than the national average.




Among young adults aged 18–25 in Illinois, the annual average percentage with SMI in the past year increased between 2008–2010 and 2017–2019.

During 2017–2019, the annual average prevalence of past-year SMI in Illinois was **8.7%** (or **115,000**), similar to both the regional average (**8.7%**) and the national average (**7.9%**).

#### **Substance Abuse**

In 2017, the U.S. Department of Health and Human Services declared a public health emergency often referred to as the Opioid Epidemic. The U.S. Department of Health and Human Services estimates over 130 people die each day of an opioid overdose. Hanover Township has not been exempt from this public health crisis. The Cook County Department of Public Health reports that in suburban Cook County, opioid related deaths continue to rise at rate higher than the national average.

In 2019, Illinois became the 11<sup>th</sup> state to legalize the sale of marijuana. Concerns about availability to minors continue to rise. In late 2019, the Illinois Department of Human Services Division of Substance Use Prevention and Recovery found that cannabis use among teens remains stable. Substance use providers worry that over time, use among teens may rise as the use of cannabis becomes normalized.

## **Developmental Disabilities**

Developmental disabilities are defined by the Center for Disease Control and Prevention (CDC) as a group of conditions due to an impairment in physical, learning, language or behavior areas. These conditions begin during the developmental period, may impact day-to-day functions, and usually last throughout a person's lifetime. Children diagnosed with a developmental disability typically require a number of treatments and services to address developmental and behavioral challenges.

Over 6 million Americans live with a developmental disability. In Illinois, there is a comprehensive network of service providers to assist people and families of those with a developmental disability, but it continues to be grossly underfunded and understaffed. The waiting time to receive services from the State of Illinois continues to be years.



# **Hanover Township Community Needs Assessment 2021**

The Mental Health Board contracted with Northern Illinois University Center for Governmental Studies (CGS) in 2021 seeking to understand the needs of persons with mental health conditions, substance abuse issues, and developmental disabilities in Hanover Township. CGS is an applied research unit that specializes in community needs assessments for health and human services organizations. A community analysis was conducted that included data about mental health, substance abuse, and developmental disabilities.

Hanover Township's 2021 population is estimated at 98,887 and contains 34,171 households. 36.5% of households in Hanover Township are households with children. Over half (51%) of Hanover Township residents who are children speak a language other than English at home. Spanish is the most commonly spoken of those languages.

#### **Focus Group Study 2021**

After reviewing the goals of the Mental Health Board, CGS submitted a proposal to employ a multimodal survey design, including focus groups with mental health service providers, mental health service users, teens, senior citizens, Spanish and English-speaking community members. A written survey was also sent to a sample population of Hanover Township.

The focus group participants and community members who completed the survey offered several suggestions that could improve services. The following items represent recommendations and actions suggested by focus group participants:

• Expand awareness of the Mental Health Board and other services offered through Hanover Township among community members through social media and in the community.

- Provide mental health prevention education and substance abuse prevention to the community.
- Increase access to training for agencies, including trauma informed training and intensive training for new mental health staff to assist with staff turnover.
- Address racial disparities in mental health services.
- Continue focus on housing and transportation.
- Provide more legal services, especially in the area of life planning for those with disabilities.

The Mental Health Board Planning Committee reviewed the suggested recommendations provided in the study to better understand the current availability of programs/services and the feasibility for the board to take action. All feedback and recommendations were considered in the creation of the strategic plan and will continue to drive the Mental Health Board in its funding and outreach activities.

# Part II: Strategic Plan

# Fiscal Year 2020-2022 Strategic Plan Review

The Mental Health Board's Fiscal Year 2020-2022 Strategic Plan focused on resident services, outreach and communication, agency support, and bilingual support. It is important to note that the COVID-19 pandemic had a profound effect on the residents of Hanover Township and changed the trajectory of some of the goals. The Needs Assessment for the prior Strategic Plan was conducted before the pandemic occurred and did not take in account the effects on the community.

In resident services, the Mental Health Board surveyed each TIDE rider and their caregiver about the possibility of expansion. TIDE is a program that provides transportation vouchers for employment or employment services to disabled residents. The pandemic had a large effect on the TIDE program because many riders were furloughed or lost their job at the beginning of the pandemic. Riders and caregivers expressed interest in expanding the program down the road but felt uncomfortable venturing into public with so many unknowns. It has taken about two years for the TIDE program to regain the pre-pandemic level of ridership. The Mental Health Board made the decision to reconsider expanding the TIDE program when riders are again comfortable attending social events. A very similar situation occurred with the support groups the Mental Health Board wanted to begin. The Mental Health Board partnered with NAMI of Schaumburg to conduct support groups for caregivers of people with mental illness. The support groups began with small numbers but were beginning to grow as the pandemic began. The Stay-At-Home orders dramatically affected these support groups and the leaders were uncomfortable conducting virtual groups. The Mental Health Board made the decision to temporarily suspend these groups and refer residents to the existing groups through Catholic Charities.

The Mental Health Board has also made a conscious effort and has been successful in elevating social media presence over the past three years. The Mental Health Board has submitted many posts to the Hanover Township Social Media Team, takes photos of meetings and events, and continues to grow awareness in the community of the funded agencies and the Mental Health Board on social media outlets.

In 2020, the Mental Health Board published and distributed a Resource Guide, in both English and Spanish. The Resource Guide was distributed among local human service agencies, libraries, police departments, all funded agencies, and schools in both English and Spanish. Moving forward, the Mental Health Board will continue to publish the Resource Guide biannually in both English and Spanish. The Mental Health Board also sponsored a few trainings for the public and for the funded agencies. The training for the public was a partnership between the Elgin Police

Department, the Community Crisis Center, Children's Advocacy Center, and the Mental Health Board. Forty-six community members attended this virtual event to learn how to help someone experiencing domestic violence.

The Mental Health Board also focused on increasing access to bilingual services while making funding decisions. The Board was pleased to fund a bilingual therapist position for Hanover Township Youth and Family Services. The Mental Health Board also funded Community Alternatives Unlimited, which provides Spanish speaking assistance in accessing state services to families in Hanover Township. The Board also provided Challenge Funding to Partners In Our Communities, an agency that works with new immigrants.

As a result of the Strategic Plan of 2020-2022 being written before the COVID-19 pandemic, there were no goals related to assisting agencies or the community. The Mental Health Board quickly pivoted their focus to assisting agencies as needs arose. For instance, in FY21, the Mental Health Board agreed to advance first quarter payments to all agencies funded through Purchase of Service to assist with costs associated with COVID. The Mental Health Board provided capital funding to many agencies to provide virtual service. The Mental Health Board coordinated a weekly grocery delivery to a residential home in the Township that serves eight residents with developmental disabilities. Discussion among funded agencies was facilitated to help them find personal protective equipment, cleaning supplies and additional available funds. The Mental Health Board will continue to prioritize recovery from the COVID-19 Pandemic in the coming years.

# Summary of Mental Health Board Strategic Plan

The Mental Health Board's Planning Committee reviewed the 2021 Needs Assessment and met to discuss the direction they would like to take based on the feedback. The Strategic Plan for FY23-25 focuses on four key areas: outreach and awareness, reporting and accountability, housing opportunities, and educational opportunities for funded agencies. The Mental Health Board understands that outreach and awareness of the Board itself is important and lacking. In addition, residents of Hanover Township seem to be unaware that services are available to them because of Mental Health Board funding. The Board is seeking to elevate the awareness of services available to the public. In addition, the Mental Health Board would like to foster more relationships with community leaders to create an awareness of mental health, substance abuse and developmental disability needs.

Reporting and accountability is crucial to funding provided by the Mental Health Board, as the Board recognizes they are a steward of the community's resources. Under the current system, reporting is cumbersome for agencies and requires multiple websites to navigate. The Board is looking to simplify the process by rebuilding the reporting website and including funding applications and lessen the time agencies need to spend on reporting.

The Hanover Township Mental Health Board remains committed to Hanover Landing, a permanent supportive housing project to be built within the Township boundaries in Elgin. As the project approaches, the Mental Health Board remains committed to the five housing vouchers they have agreed to sponsor and looks to create procedures to fill those spots. The Mental Health Board is also committed to a high quality of life at Hanover Landing and is planning on coordinating with funded agencies and other community agencies to meet the needs of the residents of Hanover Landing.

The Mental Health Board is dedicated to ensuring high quality services are provided to the residents of Hanover Township. Based on feedback from funded agencies, one of the best ways to do this is provide continuing education. The Mental Health Board will work with agencies to determine what needs exist and work to fill those educational gaps. In the interest of keeping communication open, the Mental Health Board will also begin hosting an annual funded agency meeting.

# Introduction

# **Background and Purpose**

To plan for the future, the Hanover Township Mental Health Board worked with the Northern Illinois University Center for Governmental Studies (CGS) to conduct a study of mental health, substance abuse, and developmental disability needs in Hanover Township. The study was similar to the one conducted in 2018.

This study employed a multimodal survey design, including focus groups with service providers, community leaders, service users, teens, seniors, and community members, as well as a survey of community members.

Findings will be used to assist the Hanover Township Mental Health Board in evaluating current efforts and developing priorities for the future.

# **Focus Group Methodology**

Focus groups are a type of qualitative research in which individuals with similar experiences come together to discuss a specific topic or group of topics. An advantage of focus groups is the in-depth probing of issues they foster. However, because of the small total number of participants, there is no statistical reliability. Therefore, caution should be exercised in interpreting the results because they may not be representative of the entire population.

To gain a broad understanding of mental health needs and experiences within Hanover Township, CGS staff conducted a total of nine focus groups, including three groups with community leaders/service providers, two groups with service users, one group with seniors, one group with teens, and two groups with community members. Hanover Township staff recruited participants for all the focus groups. For the teen groups, parental consent for the teens was obtained by Hanover Township staff.

Discussion guides for the focus groups were developed by CGS and Hanover Township staff. These guides may be found in Appendix A. The discussion guides were designed to assess the previous effectiveness of and future needs for mental health, substance abuse, and developmental disabilities services and programs for residents.

All groups lasted between 60 and 90 minutes. In addition to notes taken during the groups, all groups were recorded. Refreshments were served at all groups, but no other incentive was offered.

The groups were held at the following dates and locations:

No focus group was conducted with substance abuse service users due to difficulty scheduling the group with the service provider.

# **Survey Methodology**

In addition to the focus groups, an online survey was conducted in English and Spanish with residents of Hanover Township.

The questionnaire was developed by CGS and Hanover Township staff, and may be found in Appendix B.

A random sample of 4,000 individuals living in Hanover Township was provided by Marketing Systems Group. This sample included names, street addresses, and emails where available.

Each individual was sent an invitation email with a unique ID code and a link to the survey. CGS sent up to four reminder emails to those who did not respond after the initial email. These materials may be found in Appendix B. Follow-up communications are important to get responses from as high a proportion of the sample as possible, as harder to reach respondents often have different experiences and responses than easier to reach respondents. A link to the survey was also included in Hanover Township communications.

The survey was open from November 4<sup>th</sup>, 2021 to December 10<sup>th</sup>, 2021.

A total of 211 surveys were received.

# **Highlights**

- Service providers, community leaders, service users, and community members are very satisfied with the current efforts of the Hanover Township Mental Health Board.
  - > The community leaders comment that the Mental Health Board is doing a good job and that they appreciate its work.
  - The service providers state that the Mental Health Board has made a significant impact over the past three years in a number of areas including providing resources to residents, supporting and partnering with community organizations, connecting organizations with each other, and providing funding to organizations.
  - > Service users are extremely pleased with the quality of services they receive and think that the services have made a difference in their and their family's lives.
  - > Community members believe the organizations funded by the Mental Health Board are trustworthy resources.
- A number of improvements areas were identified through the focus groups and online survey for the Hanover Township Mental Health Board to focus on over the next three years, including community awareness, access to services, and availability of services.
  - The online survey results show that most Hanover Township residents know very little about the Hanover Township Mental Health Board, with about one-half of the residents being unaware that the Mental Health Board exists and almost one-third only knowing the name and nothing about it.
  - The focus groups and survey findings suggest that residents do not know about the programs and services available in Hanover Township.
  - > The focus group participants would like the Hanover Township Mental Health Board to focus on outreach and education. They discussed the need for more information in the community about mental health, substance abuse, and developmental disability issues. This need is especially great among Latinos.
  - According to the survey findings, a majority of individuals who sought support services were unable to find them in Hanover Township. The services that were difficult to find were caregiver respite services and legal assistance. Focus group participants also mention that housing and transportation should be a continued focus of the Mental Health Board.

- Lastly, the Hanover Township Mental Health Board should focus on funding more developmental disabilities services for adults. A major concern among focus group participants is once individuals with developmental disabilities graduated from school or completed transition programs there are very few services or programs available. Additionally, the focus group participants comment that the population with developmental disabilities is aging, and facilities need to be made accessible for aging in place and that caregivers are also aging and need services to help plan for the individuals with developmental disabilities once caregivers pass away.
- COVID-19 will have a great impact on mental health and substance abuse services. Service providers
  believe more individuals will be seeking mental health and substance abuse services because of
  COVID-19.

# **Focus Group Findings**

# Impact of the Hanover Township Mental Health Board over the Past Three Years

## **Community Leaders/Service Providers**

Community leaders and service providers are aware of a number of the Mental Health Board's efforts. In particular, participants appreciate that the Mental Health Board had been responsive, interested, and open to hearing from community leaders and service providers and say the Mental Health Board understands the community and is "progressive and forward thinking in meeting community needs." Group members say the Mental Health Board has been instrumental in supporting and partnering with community organizations, and in connecting agencies with each other, as well as being a resource for organizations.

Additionally, community leaders and service providers note a number of resources provided to residents by the Mental Health Board, including the Streamwood Community Resource Center, TIDE program, and supportive housing project in Elgin. One service provider states "my family plans to move to Hanover Township when they retire because the services are so good."

Over the past three years, service providers indicate that the Mental Health Board has made a difference in the area in a number of ways. They say funding has allowed their organizations to deliver consistent, quality service in the area. The group notes that the Mental Health Board provides funding for everything from capital projects to professional development training for staff. Service providers comment that the Mental Health Board is "one of the most flexible, understanding funding sources. They are interested in your success."

All the community leaders and service providers express an appreciation for the work the Hanover Township Mental Health Board has been doing.

#### **Service Users**

Those participants who have used mental health services provided by Hanover Township say those services had been helpful and they are very satisfied. One participant comments that in terms of having the services people need, "I think they are doing well and covering the bases. Everything I have needed

or come upon has been available. I have not had to search out of the area." Another participant mentions that the mental health services provided by Hanover Township are "superior to those received in other places I have lived."

Individuals with developmental disabilities have used the TIDE Program offered by the Hanover Township Mental Health Board. Overall, participants are positive about this service, saying that it allows them employment and frees up time for their caregiver.

#### **Community Members**

Several community members are aware of the mental health and substance abuse services available through the Hanover Township Mental Health Board and have had positive experiences with the services.

Latino community members look to Centro de Información, which is funded by the Hanover Township Mental Health Board, to provide information on mental health, substance abuse, and developmental disabilities services. Also, several participants indicate that the Centro de Información is a trustworthy resource and could provide referrals and references to service providers.

Seniors are aware of some of the services provided by the Hanover Township Mental Health Board and would contact the Senior Center if they needed more information about mental health, substance abuse, and developmental services. They have heard positive things about the services provided by the Hanover Township Mental Health Board.

Teens seemed broadly positive about the adults in their teen leadership group at the Hanover Township Department of Youth and Family Services. The staff of the leadership groups are considered to be trustworthy and nonjudgmental.

#### **Mental Health**

#### **Improvement Areas**

Focus group participants suggest that the following mental health areas be the focus for the Mental Health Board for the next three years:

- Community awareness,
- Availability of services,

- Access to services, and
- Cost of services.

#### Community awareness

Service users want to see more information in the community about mental health issues. They think that stigma surrounding mental illness might be a barrier to getting services for some individuals.

Similarly, the teens suggest that mental health should be more widely talked about, both in school and at home. They feel that reducing the stigma about mental illness would make it easier to tell others about struggles with mental health. They report that if they told adults at school about mental health issues some would not care and some would overreact and "call the psychiatric hospital." The teens also mention that they can't talk to their parents about mental health problems. In general, teens say mental health issues aren't being talked about in school and at home and they do not have access to good information about the realities of mental health.

Service providers also see stigma around mental health as an issue, particularly among children and teens.

Community members, especially Latino community members, see stigma and denial about mental health issues as a problem. As one Latino participant states "mental health problems are not a thing in my culture."

Several service providers suggest that the Mental Health Board do more awareness and communication about the availability of services, particularly at schools, groceries, laundromats, and community events. The service providers state that "we need go where they are." Service providers also suggest that the Hanover Township Mental Health Board Resource Guide be posted in a more conspicuous place, such as the home page of Hanover Township's website.

The teens are interested in information about how to get help about depression, anxiety, and suicidal thoughts. They suggest that social media, such as TikTok might be a possible source of information if this was offered.

The service users want to see more information about and marketing for available services. They didn't think many people in the area knew what services were offered through the Township.

Community members are unaware of the services that are available in the area and think information is needed.

Teens stress the importance of a previous, trusting relationship with someone for them to feel comfortable talking to that person about mental health issues. They would like someone they can have a discussion with rather than being talked at. However, teens do not always think there is someone knowledgeable they could talk to about mental health issues and think that it might be difficult to get help for such issues. There is an overall perception that adults might not understand or accept that teens have mental health issues, or that they would not necessarily take action to help. Some teens fear their parents would not accept mental health problems. They suggest that information should be provided for parents that would help them help their teens, instead of making the situation more difficult.

Most teens do not know where to go for assistance with mental health issues. Access to medical care is limited if a teen is not able to speak to a parent about mental health concerns.

## Availability of services

Service providers note a shortage of specific types of professionals, including psychiatrists, particularly those that treat children and those that are bilingual.

Service providers are concerned about being able to hire qualified staff, noting that fewer people are going into the mental health care field, that candidates are not well qualified, and that they have not been able to pay competitive salaries. Some providers are concerned about newly qualified provider, indicating that students are leaving Masters programs without foundational skills, like writing, and real-world experience. Another concern is clients with the greatest needs being served by bachelor's level case managers, as higher-level providers would want to take an easier job (lower caseload and fewer hours) with better pay, and salaries are not competitive in public service.

Service providers are also concerned about the amount of staff turnover. They comment that "fewer than 20% of individuals transition to a new therapist if their therapist leaves, they would rather not go see a new person. Building rapport or re-telling their story can re retraumatizing."

Community leaders state that there is not enough long-term care in the Township for chronic or recurring mental health issues.

Some service providers say there is not enough respite care available for caregivers of individuals who have a mental health issue.

Service providers and community leaders agree that housing, including supportive housing that is integrated into the community, should be a continuing focus for the Mental Health Board. One community leader suggests that a housing first model would be helpful. They comment "get them housed and then deal with everything else. If you are unhoused, you can't deal with anything else."

Community leaders, service providers, and community members discuss the need for more service providers who could provide low-cost care, particularly for people without medical insurance. Community leaders and service providers also mention the need for services for undocumented individuals.

Community leaders state that more service providers that are trauma informed trained are needed "because trauma is where the vast majority of mental health issues come from."

Service providers and community leaders indicate that there is a need for mental health professionals who speak Spanish. Latino community members report that it is very difficult to find mental health providers who speak Spanish. One community member states, "bilingual staff can give us confidence to ask questions, schedule appointments, etc."

Community leaders would like to see specialists added in Hanover Township that deal with transgender and LGBQ youth.

Service provision for individuals in the justice is seen by some service providers to be a particular challenge. Obtaining employment and housing is very difficult for them. One service provider comments, "all agencies service that group, but there is no specific service for them."

Community members would like to see a grief support group added in Hanover Township.

#### Access to services

Community leaders comment that the amount of required paperwork to receive services is a deterrent for some people. They state, "people get bogged down with completing paperwork and can't receive services."

Service providers see long wait lists, sometimes up to a year or two years, depending on the agency as a barrier to care. One service provider comments, "by the time you could get services, whatever you were dealing with could not be an issue anymore."

According to the service providers, the times when services are provided have gotten better, though there is still a long way to go. The service providers mention "hours are more flexible but there aren't enough evening and weekend hours." Community members comment that scheduling appointments with mental health professionals is a problem, especially for those working long hours.

Transportation is a concern according to the service providers and community leaders. The participants think that the TIDE program is good, but it is just for individuals with developmental disabilities. They state that public transportation is better than before but still limited in times and hours. As one participant comments "this is a suburban area. If you don't have a car, you aren't getting there."

Service providers perceive a lack of childcare as another barrier to care and better mental health.

# Cost of Services

Costs and insurance coverage are a major concern for participants. For community members, lack of insurance or insurance with high deductibles and copays, as well as few providers accepting certain types of insurance, are seen as a barrier to care. Additionally, access to medications due to cost is a concern, particularly for medications not covered by insurance.

Community members state that mental health care is too expensive to access. In particular, participants say that they knew people who made too much to qualify for low-cost services, but too little to afford services on their own.

Cost is also a concern for teens, as counseling is perceived to be expensive.

For service providers, low reimbursements, particularly from Medicaid, are a concern.

#### **Participant Suggested Actions and Priorities**

Participants have a number of suggestions for future directions for the Mental Health Board.

Almost all the participants think the Mental Health Board should do more awareness and communication about mental illness and availability of services. They suggest communicating information to residents in both English and Spanish, using a variety of methods including mailings, online, events, and through schools and Centro de Información. Additionally, the Mental Health Board should provide more information on their web page.

Service providers and community leaders would like the TIDE program to be expanded to individuals with mental health and substance abuse issues.

Service providers suggest that the Mental Health Board provide more mental health prevention education.

Service providers report that staff need trauma informed training and would like the Mental Health Board to provide funding for the training.

A service provider suggests that money for training be used for intensive training for new mental health professional staff, and that the existing training grant be increased, as it is currently inadequate to provide training and onboarding for these new staff.

Service providers would like to see the intake process streamlined and information shared across agencies rather than having an individual provide the information multiple times to each of the agencies.

## **Substance Abuse**

#### **Improvement Areas**

The focus group participants suggest the following substance abuse areas be the focus for the Mental Health Board for the next three years:

- Community awareness,
- Continuity/coordination of care,
- Availability of services,
- Access to services, and
- Cost of services.

#### Community awareness

Many community members are not aware of the substance abuse programs available in the area. Latino community members would turn to the Centro de Información for information about substance abuse services in the community. They also say they might turn to the internet, their primary care physician, libraries, and churches. Community members would also like information about where to obtain services for teens.

Several community members say they are not sure where to go to get information about drugs and vaping, and to get information about how to help teens using drugs and vaping. The community members report that vaping is beginning in middle school. They suggest that parents need information about how to recognize drug use and address it. Stigma and concern about confidentiality is an issue, with some participants stressing that drug use is too important for parents to keep silent about, and that the community should talk about it and help each other.

Community members mention that information about alcohol and drugs and information about what substance abuse services are available for Hanover Township residents are not available in Spanish.

Teens' information about substance abuse comes mostly from classes at schools. While some participants indicate that their classes are not particularly useful or current, others say that their schools provide resources and help them think critically about substance use. Teens say they do not see their parents as a good source of information.

Teens cite a number of people they could talk to if had a drug or alcohol problem. Some say that they can talk to their school social worker or staff at their teen group because they are trustworthy. Most teens state that they could not talk to their parents about a drug or alcohol problem.

According to the service providers and community members opioids are a major concern. There is a concern about an education gap—that individuals are being saved from overdose, but the root causes of use was not being addressed. In particular, participants are concerned about prescription drug use and abuse.

Community leaders indicate there is a need to increase awareness of gambling addiction services. They state that "gamblers typically don't seek treatment until it is too late."

# Continuity/coordination of care

Overall, a concern among the service providers is that substance abuse is often treated like an acute illness, instead of a chronic one needing ongoing treatment. Participants report that some individuals who had overdosed are being released within hours of the overdose, instead of receiving additional treatment. It is suggested that individuals who have overdosed be connected to services while still at the hospital, and that a clear treatment protocol should exist for these individuals.

#### Availability of services

Because mental illness and substance abuse often occur together, service providers say there is need for specialists dealing with this comorbidity. They comment that Ecker Center providing both mental health and substance abuse services is a good first step.

Latino community members mention that substance abuse treatment services and support systems are not available in Spanish.

#### Access to services

Though service providers say that entry level residential substance abuse treatment services are relatively easy to obtain, some say it is difficult to place patients into higher level residential services. Providers indicate that too few beds were available, and that insurance plans often do not cover residential

substance abuse care.

Service providers mention transportation as a concern in the Hanover Township area. They note that transportation to services is a barrier to access since most alcoholics do not have driver licenses.

Teens mention that confidentiality is a barrier to getting substance abuse treatment. They fear that their parents will be notified they are receiving treatment.

#### Cost of services

The cost of substance abuse services is a concern for some of the community members. Service providers also think that the cost of substance abuse services is a barrier to obtaining treatment, particularly for those who are uninsured or underinsured.

#### **Participant Suggested Actions and Priorities**

Participants have a number of suggestions for the Mental Health Board regarding substance abuse services.

As with mental health issues, participants suggest that the Mental Health Board be involved in substance abuse prevention education, especially for families with children.

Like mental health issues, service providers believe trauma is the cause of substance abuse addiction. They suggest that staff need trauma informed training and would like the Mental Health Board to provide funding for the training.

Teens suggest that there be discussion groups about substance use run by individuals they trust. Teens indicate that this might deter them from using drugs and/or alcohol.

# **Developmental Disabilities**

# **Improvement Areas**

The focus group participants suggest that the following developmental disabilities areas be the focus of the Hanover Township Mental Health Board for the next three years:

- Community awareness,
- Continuity/coordination of care,
- Availability of services,
- Access to services, and
- Cost of services.

#### Community awareness

Service providers and community members state that awareness of available services, especially for adults with developmental disabilities, is low. Additionally, they comment that it is difficult to find a source of information for services and programs for adults with developmental disabilities.

#### Availability of services

Community leaders mention the lack of services for adults with developmental disabilities. They indicate that services are easier to obtain for people with developmental disabilities of school age. However, after these individuals graduate or complete transition programs, very few services or programs are available.

In general, service providers say services for people with developmental disabilities, especially adults, are either limited or not available. In particular, participants note a need for therapists trained to work with people with developmental disabilities.

Individuals with developmental disabilities express that they are satisfied with the TIDE program however there have been times when they were picked up late or not picked up at all.

Service providers discuss the needs of adults with developmental disabilities living with parents or other family caregivers. Several service providers see a need for more caregiver respite services and other supports for caregivers.

Service providers also see a need for supportive housing for individuals with developmental disabilities.

Additionally, service providers comment that the population with developmental disabilities is aging, and facilities need to be made accessible for aging in place.

Service providers think that severe and profound autism is increasing in the population and that additional services will be needed soon to accommodate these individuals.

#### Access to services

Service providers comment that the application and qualification process for service is a concern. Because services are often provided by multiple organizations, caregivers have to find and research multiple organizations, complete multiple applications, and confusing or difficult qualification requirements. Participants suggest providing assistance for those applying for services and a streamlined application process.

In addition to the application process, long wait lists for services are a concern.

#### Continuity/coordination of care

Service providers would like to see better case management and coordination of care and services, particularly for adults with developmental disabilities.

General feedback on transition services offered by Center House is very good, with some individuals with developmental disabilities indicating that these services were life changing.

There is major concern about caregiver transition among participants. They mention that caregivers are aging and need services to help plan on what will happen to the person with developmental disabilities they are caring for once they die.

#### Costs of services

In particular, the cost of transportation is a concern for individuals with developmental disabilities. Those with developmental disabilities earn very little money. One participant reports that TIDE services "get to be expensive."

#### **Participant Suggested Actions and Priorities**

Service providers and community members suggest that the Mental Health Board increase awareness of services and programs available in the Township for adults with developmental disabilities.

Participants would like the Mental Health Board to help fund a service that will help caregivers plan for what will happen to individuals with developmental disabilities they are caring for once they die.

Service providers see the need for more services for individuals with autism and would like the Mental Health Board to provide funding for these services.

# **General Suggestions for Mental Health Board Actions and Priorities**

Participants provide three general suggestions for Mental Health Board actions and priorities over the next three years. These suggestions cut across the three areas of mental health, substance abuse, and developmental disabilities.

Participants would like the Mental Health Board to address racial disparities in mental health and services.

Service providers want the Mental Health Board to continue to focus on funding/providing housing and transportation.

Participants would like the Mental Health Board to provide more legal services.

# **Impact of COVID-19**

COVID-19 will have a great impact on mental health and substance abuse services. Service providers believe more individuals will be seeking mental health and substance abuse services because of COVID-19.

Community members, especially seniors, comment that isolation has made them feel lonely, anxious, and depressed.

Service providers believe COVID-19 has had a significant impact on children. They comment that children

have experienced a lack of socialization and delayed language development because of wearing masked.

Service providers think that when the stimulus, child credit, and eviction moratorium end needs will increase for shelter, food, and supplies such as toiletries.

Lastly, participant think that COVID-19 has increased the need for caregiver respite services.


## **Community Survey Findings**

## **Demographics**

#### **Household Characteristics**

The majority of respondents are from Hanover Park (39.4%), Elgin (19.2%), Streamwood (17.3%), and Bartlett (16.3%). Less than five percent live in Hoffman Estates (3.8%) and Schaumburg (3.8%).

One in six (17.1.%) households report a 2020 household income level of under \$35,000, while over a quarter (27.7%) have an annual household income of \$100,000 or more. <sup>1</sup>



One-third (34.0%) report that a language other than English is spoken in their household. The most common language spoken is Spanish.


Household size ranges from one to nine, with a mean household size of 2.9. About one-third (32.7%) of households have children. Number of children in these household ranges from one to four, with a mean of 2.0 children in each household with children.


#### **Individual Characteristics**

Two-thirds (66.0%) of respondents are female, and 34.0% are male.


Relatively few respondents (2.0%) are aged 18 to 29, while 11.1% are 30 to 39, 23.2% are 40 to 49, and 22.2% are 50 to 59. About two in five (41.4%) are 60 or older; 19.2% are 60 to 69, 19.2% are 70 to 79, and 3.0% are over 80.



Seven in ten (71.8%) are White or Caucasian, 13.6% are Latino or Hispanic, 6.8% are Black or African American, 5.8% are Asian or Pacific Islander. Less than one in ten (1.9%%) say they identify with more than one race, and none identify as Native American or a race other than those listed.



The majority of respondents (82.5%) have attended at least some college, with 54.3.% having at least a bachelor's degree. About one in six (17.5.%) have not attended college; 1.0% of those surveyed have less than a high school degree and 16.5% have a high school diploma or GED.



#### Health Care Coverage

Most (97.0%) respondents indicate that they have health care coverage. Almost one-half (47.5%) have a private plan purchased through an employer or union, or by someone in the household. More than one-third (36.4%) of respondents say their primary health care coverage was through Medicare, 8.1% have Medicaid or another state program, and 1.0% are covered by military health coverage. Relatively few (4.0%) respondents have a type of coverage other than those listed here, and 3.0% of respondents do not have health care coverage.

In households with more than one person, most (74.0%) indicate that all members of their household have the same type of health care coverage. Among households with more than one type of health coverage, it is very common for at least one person to have some type of public health care coverage, such as Medicare, Medicaid, or All Kids.

## **Overall Perceptions**

Respondents were asked to name the biggest issues or needs related to mental health, substance abuse, and developmental disabilities in Hanover Township. Responses to this question were then divided into broad categories.

One-third (33.3%) of respondents state that better communication or information about services is the biggest need. Typically, respondents say they do not know what services are available, or where to go for help if needed. In 2018, 25.3% of respondents reported that better communication or information about services is needed.

One in six (16.7.%) respondents comment access to services, including cost and wait times for such services, is the biggest concern. Many are concerned that they would not be able to use services if needed, primarily because they would have to wait too long, or they could not afford the services.


Mental health services including, sufficient service providers, such as psychiatrists and therapists are the biggest concern cited by 13.9% of respondents.

Next, respondents were asked about their familiarity with the Hanover Township Mental Health Board and what it does.

About one-half of the respondents are still unaware the Mental Health Board exists (51.0%, 2018; 51.3% 2021). Three in ten (30.3%) have only heard the name. About one in ten (10.5%) indicate they know a little about the Mental Health Board, and only 7.9% know a moderate amount (5.3%) or a great deal (2.6%) about it.




## **Mental Health**

Respondents were asked a series of questions about mental health. First, all respondents were asked questions about their perceptions of how hard it would be to access certain types of mental health services. Then, those who had sought mental health services in the past three years were asked if they were able to find these services in Hanover Township.

Overall, more than one-half (53.3%) of respondents state they or someone in their household had some type of mental health problem. More than one-fifth (22.8%) indicate that they or someone in their household have sought mental health services in Hanover Township in the past three years.

#### Information about Mental Health Services

Two-thirds (65.7%) of respondents think it would be very easy (19.0%) or somewhat easy (46.7%) to get information about the mental health services available in Hanover Township. More than one-quarter (28.6%) think it would be somewhat hard and 5.7% think it would be very hard to find this information. These findings are similar to those obtained in 2018.



Those respondents who said someone in their household has a mental health problem are nearly twice as likely as those who did not to say it would be hard to get information about mental health services. More than two-fifths (43.8%) of households where someone has a mental health issue say it would be somewhat or very hard to get information about mental health services, compared to more than one-fifth (23.4%) of households that did not report a household member with a mental health problem.<sup>2</sup>

In 2018, 40.2% of households where someone had a mental health issue said it would be somewhat or very hard to get information about mental health services, compared to 21.3% households that did not report a household member with a mental health problem.


Most commonly, respondents who think it would be hard to find such information state they do not know where to look for it (91.7% of those who thought it would be somewhat or very hard to find this information). One-third (33.3%) say that available information is not specific to Hanover Township, and 8.3% indicate that information is only available on the internet. Very few (2.8%) say that information is not available in their language; however, as the survey was in English and Spanish only, this percentage may be higher in the general population of Hanover Township residents. Similar findings were obtained in 2018.

#### **Mental Health Assessment and Diagnosis**

More than one-half (54.8%) of all respondents think it would be very easy (12.5%) or somewhat easy (42.3%) to get a psychological assessment and diagnosis in Hanover Township, while one-third (33.7%) state it would be somewhat hard and 11.5.% say it would be very hard. These findings are similar to those obtained in 2018.



Again, those respondents with a household member with a mental health problem are more likely than those without to say that it would be hard to get services. While more than one-half (54.4%) of those in households with a household member with a mental health problems state it would be somewhat or very hard to get a psychological assessment and diagnosis, one-third (34.8%) of those in a household where no one had a mental health problem state these services would be hard to get.

In 2018, 50.0% of households where someone had a mental health issue said it would be somewhat or very hard to get a psychological assessment and diagnosis in Hanover Township, compared to 30.8% households that did not report a household member with a mental health problem.


Among those who think that it would be somewhat or very hard to get a psychological assessment and diagnosis, more than four-fifths (85.1%) say they did not know where to go or who to see. More than one-half (57.4%) are concerned about the cost of service; an increase from 2018 when 44.6% were concerned about the cost of service, and 42.6% say there are long wait times to get an appointment.

#### **Mental Health Treatment or Care**

One-half (50.0%) of respondents think that it would be very easy (13.5%) or somewhat easy (36.5%) to get treatment or care for mental health problems in Hanover Township, while 43.3% say it would be somewhat hard and 6.7% say it would be very hard. Similar findings were obtained in 2018.



Three-fifths (59.7%) of respondents with a household member with a mental health problem state it would be somewhat or very hard to get mental health treatment or care, compared to 39.1% of households with no members with mental health problems.

In 2018, 56.3% of households where someone had a mental health issue said it would be somewhat or very hard to get mental health treatment or care in Hanover Township, compared to 36.2% households that did not report a household member with a mental health problem.

Among those who think it would be hard to get treatment or care for a mental health problem, the most common reason is not knowing where to go or who to see (78.8%), followed by cost of service (50.0%), not enough mental health professionals in Hanover Township (40.4%), and long wait times to get an appointment (36.5%). The percentage of respondents who indicate there are not enough mental health professionals in the Township has increased 9.1 percentage points since 2018 when it was 31.3%



Of those respondents who say they or someone in their household have sought treatment or care for a mental health problem, 53.8% say they were able to find it. A total of 46.2% respondents were unable to find needed treatment or care. The most frequently mentioned treatment or care services they were unable to find in Hanover Township are:

- Individual therapy
- Psychiatrist provided services
- Child services
- Teen or adolescent services

## Mental Health Support Services

More than two-fifths (42.3%) of respondents think it would be very easy (10.6%) or somewhat easy (31.7%) to get support services, such as housing, transportation, or job assistance, if they or someone in their household needed them, while 42.3% think it would be somewhat hard and 15.4% think it would be very hard to get these services. These findings are similar to those obtained in 2018.



More than three-fifths (63.2%) of respondents in households where someone has a mental health problem say it would be very or somewhat hard to get mental health support services and 52.2% of those in households where no one had a mental health problem indicate that these services would be hard to get.

In 2018, 71.6% of respondents in households where someone has a mental health issue stated it would be very or somewhat hard to get mental health support and 47.7% of those in household where no one had a mental health issue indicated that these services would be hard to get.


#### **Substance Abuse**

Next, respondents were asked a series of questions about addiction and substance abuse. First, all respondents were asked questions about their perceptions of how hard it would be to access certain types of substance abuse treatment services. Then, those who had sought such services in the past three years were asked if they were able to find them in Hanover Township.

Overall, more than one in ten (13.0%) respondents report they or someone in their household has some type of addiction or substance abuse problem, and 14.3% indicate that they or someone in their household have sought services for substance abuse or addiction in Hanover Township in the past three years.

## Information about Substance Abuse Treatment Services

Similar to the 2018 findings, two-thirds (66.3%) of respondents think it would be very easy (15.8%) or somewhat easy (50.5%) to get information about addiction and substance abuse treatment services available in Hanover Township. A total of 29.7% think it would be somewhat hard and 4.0% think it would be very hard to find this information.



Almost two-fifths (38.5%) of households where someone has an addiction concern say it would be somewhat or very hard to get information about substance abuse services; a decrease of 9.5 percentage points since 2018 when 48.0% indicated it would be somewhat or very hard to get information about substance abuse services in the Township. A total of 32.9% of households that do not report a household member with an addiction problem say it would be somewhat or very hard to get information.



#### Substance Abuse Assessment

About six in ten (59.0%) respondents think it would be very easy (12.0%) or somewhat easy (47.0%) to get a substance abuse assessment in Hanover Township, while 37.0% say it would be somewhat hard and 4.0% say it would be very hard. These findings are similar to those obtained in 2018.



Again, those respondents with a household member with a substance abuse or addiction problem are more likely than those without to say that it would be hard to get services. While 61.5% of those with a household member with a substance abuse or addiction problem say it would be somewhat or very hard to get a substance abuse assessment, only 37.9% of those in a household where no one has a substance abuse problem say these services would be hard to get.



Among those who think that it would be somewhat or very hard to get a substance abuse assessment, the majority (87.8%) say that they do not know where to go or who to see, while 43.9 % cite the cost of service. Similar findings were obtained in 2018.

Of those respondents who say they or someone in their household have sought a substance abuse or gambling assessment, the majority say they were able to find it in Hanover Township (60.0%,2021; 66.7%, 2018).

Three in five (59.4%) respondents say that it would be very easy (11.9%) or somewhat easy (47.5%) to get treatment or care for substance abuse problems in Hanover Township, while 34.7% say it would be somewhat hard and 5.9% say it would be very hard. These findings are the same as those obtained in 2018.



One-half (50.0%) of respondents with a household member with a substance abuse or gambling problem say it would be somewhat or very hard to get treatment or care; a decrease of 11.5 percentage points from 2018 when 61.5% of respondents with a household member with a substance abuse or gambling problem indicated it would be somewhat or very hard to get treatment or care. A total of 39.1% of households with no members with these issues say it would be somewhat or very hard to get treatment or care.



Of those respondents who say they or someone in their household have sought treatment or care for a substance abuse problem, 50.0% say they were able to find it. A total of 50.0% were unable to find needed treatment or care, including the following specific services:

- Crisis assistance
- Inpatient treatment
- Outpatient treatment
- Group therapy
- Individual therapy
- Psychiatrist provided services

One-half (50.5%) of respondents think it would be very easy (8.1%) or somewhat easy (42.4%) to get support services, such as housing, transportation, or job assistance, if they or someone in their household needed them, while 35.4% think it would be somewhat hard and 14.1% think it would be very hard to get these services. A smaller percentage of respondents indicate in 2021 than in 2018 that it would be somewhat hard to get substance abuse support services.



No statistically significant difference in perceived difficulty of getting support services exists between households with and without a member with a substance abuse problem.

Most commonly, respondents who think it would be hard to get support services say that they do not know where to go or who to see (91.8%). In 2018, 81.9% of respondents who indicated it would be hard to get support services stated that they do not know where to go or who to see.


## **Developmental Disabilities**

Then, respondents were asked a series of questions about services for people with developmental disabilities. First, all respondents were asked questions about their perceptions of how hard it would be to access certain types of services for people with developmental disabilities. Then, those who had sought such services in the past three years were asked if they were able to find them in Hanover Township.

Overall, about one in five (21.7%) respondents say they or someone in their household have a developmental disability, and 22.7% indicate that they or someone in their household have sought services for individuals with developmental disabilities in Hanover Township in the past three years.

#### Information about Services for People with Developmental Disabilities

Almost three-fifths (58.1%) of respondents think it would be very easy (16.2%) or somewhat easy (41.9%) to get information about available services for individuals with developmental disabilities in Hanover Township. Just less than one-third (32.4%) think it would be somewhat hard and 9.5% think it would be very hard to find this information. These findings are similar to those obtained in 2018.



No statistically significant difference in perceived difficulty of getting any type of services for people with developmental disabilities exists between households with and without a member with a developmental disability.


Most commonly, respondents who think it would be difficult to find such information say they do not know where to look for information (86.4%) of those who think it would be somewhat or very hard to find information). Almost one-third (31.8%) say that available information is not specific to Hanover Township,

#### **Developmental Disabilities Assessment and Diagnosis**

More than one-half (54.4%) of respondents think it would be very easy (11.7%) or somewhat easy (42.7%) to get a developmental disability assessment and diagnosis in Hanover Township, while one-third (34.0%) say it would be somewhat hard and 11.7% say it would be very hard. The percentage of respondents who indicate it would be somewhat or very hard to get a developmental disability assessment and diagnosis in Hanover has increased since 2018 (34.1%, 2018; 45.7%, 2021).



Among those who think that it would be somewhat or very hard to get a developmental disability assessment and diagnosis, the majority (83.0%) say that they do not know where to go or who to see, while two in five cite the cost of service (40.4%) and are concerned about long wait times to get an

appointment (40.4%).



The percentage of respondents who report lack of public transportation makes it difficult to get a development disability assessment and diagnosis increased from 2018 (2018, 9.8%; 2021, 21.3%).

Like in 2018 the majority of those respondents who say they or someone in their household has sought an assessment or diagnosis indicate they were able to find it in Hanover Township (2018, 66.7%; 2021, 65.0%).

#### Treatment or Care for People with Developmental Disabilities

More than one-half (53.4%) of respondents say that it would be very easy (10.7%) or somewhat easy (42.7%) to get treatment or care for an individual with a developmental disability in Hanover Township, while more than one-third (35.0%) say it would be somewhat hard and about one in ten (11.7%) say it would be very hard. These findings are similar to those obtained in 2018.



Among those who thought it would be hard to get treatment or care, the most common reason was not knowing where to go or who to see (87.5%).


The percentage of respondents who indicate they do not where to go or who to see (2021, 87.5%; 2018, 72.2%) and the percentage of respondents who indicate there are not enough developmental disability health professionals in Hanover Township (2021, 39.6%; 2018, 27.8%) has increased since 2018.

Of those respondents who say they or someone in their household has sought treatment or care for a person with a developmental disability, (20.0%) report they were able to find it. Four-fifths (80.0%) were unable to find needed treatment or care, including the following specific services:

- Behavior therapy and counseling
- Speech and language therapy
- Occupational therapy
- Art or music therapy

#### Support Services for Individuals with Developmental Disabilities

More two-fifths (45.7%) of respondents think it would be very easy (7.8%) or somewhat easy (37.9%) to get support services, such as housing, transportation, or job assistance, if they or someone in their household needed them, while 41.7% think it would be somewhat hard and 12.0% think it would be very hard to get these services. These findings are similar to those obtained in 2018.



Most commonly, respondents who think it would be hard to find such support services say they do not know where to go or who to see (83.9%). Similar findings were obtained in 2018.

Of those respondents who say they or someone in their household have sought support services for someone with a developmental disability, 50.0% say they were able to find them. One-half (50.0%) were unable to find needed support services, including the following specific services:

- Caregiver respite
- Housing
- Job search and placement assistance
- Assistance with education or schooling

## **Conclusions and Recommendations**

Service providers, community leaders, service users, and community members are very satisfied with the current efforts of the Hanover Township Mental Health Board. The service providers stated that the Mental Health Board has made a significant impact over the past three years in a number of areas including providing resources to residents, supporting and partnering with community organizations, and providing funding to organizations. Service users are extremely pleased with the quality of mental health, substance abuse, and developmental disabilities services they receive and state that the services have made a difference in their and their family's lives. Community members believe the organizations funded by the Mental Health Board are trustworthy resources.

A number of improvements areas were identified through the focus groups and online survey for the Hanover Township Mental Health Board to focus on over the next three years. The main priority is increasing **community awareness**. Communication is needed about 1) the Hanover Township Mental Health Board and what it does, 2) the mental health, substance abuse, and developmental disabilities services available in Hanover Township, and 3) about various mental health, addiction and substance abuse, and developmental disabilities concerns.

The online survey results show that most Hanover Township residents know very little about the Hanover Township Mental Health Board, with about one-half of the residents being unaware that the Mental Health Board exists and one in three only knowing the name and nothing about it. Information about the Mental Health Board and what it does should be communicated on a regular basis to residents.

The focus groups and survey findings suggest that residents do not know about the services available in Hanover Township. The resource guide developed by the Hanover Township Mental Health Board needs to be placed more prominently on the Mental Health Board web page and/or on the Hanover Township web page. Communications about the Hanover Township Mental Health Board should include information about the resource guide and a link to the guide on the Mental Health Board's web page. Community members indicate that they look to libraries, schools, churches, and organizations such as the Centro de Información for this type of information. These entities should be made aware of and sent the resource guide as well.

Lastly, the focus group participants would like the Hanover Township Mental Health Board to focus on outreach and education. They discussed the need for more information in the community about mental health issues and how this might help alleviate the stigma surrounding mental health. Community members would like information about alcohol and drug use, particularly about how to recognize drug use and address it in teens. Teens suggest that there be discussion groups with trustworthy individuals to address substance abuse.

Also, community members want to see the Mental Health Board focus on outreach and education, particularly within the Latino community. Several suggested a focus on working with parents, which would allow the parents to better help their children. Similarly, service providers suggested greater outreach and education for families with children. Outreach and education could include information for parents on a variety of topics, such as mental health and substance abuse prevention and how to identify mental health and substance abuse issues.

Another priority that the Hanover Township Mental Health Board should address is the **availability of support services**. According to the survey findings, a majority of individuals who sought support services were unable to find them in Hanover Township. The services that were difficult to find were caregiver respite, transportation, housing, job search and placement, and legal assistance services. Focus group participants also mention that housing, especially supportive housing, and transportation should be a continued focus of the Mental Health Board.

the Hanover Township Mental Health Board should focus on **funding more developmental disabilities services for adults**. A major concern of focus group participants for was that, once individuals with developmental disabilities graduate from school or complete transition programs, there are very few services or programs available. They commented that there were long wait lists for the existing services and programs. Additionally, participants indicate a need for a service that would assist caregivers plan for what will happen to the individual with developmental disability once the caregiver dies.

Lastly, the Hanover Township Mental Health Board should consider how the additional community needs that are the result of COVID-19 can be addressed.


