Hanover Township Mental Health Board Minutes April 25, 2023

The meeting was called to order by Chair Kathy Biesiadecki at 6:32 pm.

Roll Call: Mary Jane Garvey, Denise Noyola, Matthew Steichmann, Kathy Biesiadecki, and Michelle Esquivel. Also in attendance, Mental Health Board Manager Amanda Teachout and Melanie Pignotti of Children's Advocacy Center

This means that Mental Health Services would be cut if there is not an influx of revenue.
