ORDINANCE NO. 101723

AN ORDINANCE AMENDING THE RULES FOR ELECTRONIC ATTENDANCE AT HANOVER TOWNSHIP BOARD MEETINGS

WHEREAS, pursuant to the Illinois Open Meetings Act (the "Act"), 5 ILCS 120/1 et seq., a public body must adopt rules which conform to the requirements and restrictions of Section 7 thereof in order to permit the attendance of members at meetings by means other than physical presence; and

WHEREAS, on April 22, 2014, the Supervisor and Board of Trustees of Hanover Township (collectively, the "Township Board") adopted Ordinance No. 042214_Electronic, "An Ordinance Adopting Rules for Electronic Attendance at Hanover Township Board Meetings," to permit the attendance of Board members at meetings other than by physical presence; and

WHEREAS, the Township Board has reviewed the Rules for Electronic Attendance at Hanover Township Board Meetings thereby adopted and deems it necessary and appropriate to the efficient and orderly conduct of its meetings to amend the same, inter alia, to conform with changes in applicable statutes, technology, and preferred practices, as more fully set forth herein; and

NOW, THEREFORE, BE IT ORDAINED by the Supervisor and Board of Trustees of Hanover Township, Cook County, Illinois, as follows:

SECTION ONE: INCORPORATION OF RECITALS. The foregoing recitals and all exhibits referenced therein are hereby incorporated into the body of this Ordinance as though fully set forth herein.

SECTION TWO: ADOPTION. The amended Rules for Electronic Attendance at Hanover Township Board Meetings, a copy of which is attached hereto and hereby incorporated into the body of this Ordinance as though fully set forth herein, is hereby adopted and approved.

SECTION TWO:

SEVERABILITY. If any section, paragraph, or provision of this

Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Ordinance.

REPEALER. All prior Ordinances and Resolutions in conflict SECTION THREE: or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

EFFECTIVE DATE. This Ordinance shall be in full force and SECTION FOUR: effect upon its passage and approval.
