## A RESOLUTION TO DELEGATE AUTHORITY TO THE TOWNSHIP BOARD TO PURCHASE, SELL, AND LEASE PROPERTY

WHEREAS, pursuant to Section 85-10 of the Township Code (the "Code"), 60 ILCS 1/85-10, Hanover Township may acquire and hold property, both real and personal, for the use of its inhabitants and may sell and convey that property; and

WHEREAS, pursuant to Section 30-50 of the Code, 60 ILCS 1/30-50, the Electors of Hanover Township (the "Electors") may make all orders for the purchase, sale, conveyance, regulation, or use of Hanover Township's corporate property that may be deemed conducive to the interest of its inhabitants; and

WHEREAS, pursuant to Public Act 100-0893, the Electors may delegate the power to purchase, sell, or lease property to the Supervisor and Board of Trustees of Hanover Township (the "Board") for a period of up to twelve (12) months; and

WHEREAS, the Electors deem it conducive and in the best interest of residents of Hanover Township to delegate the power to purchase, sell, or lease property to the Board for a period of twelve (12) months; and

NOW, THEREFORE, BE IT RESOLVED by the Electors of Hanover Township duly assembled at the 173<sup>rd</sup> Township Meeting of Hanover Township, Cook County, Illinois, as follows:

SECTION ONE: INCORPORATION OF RECITALS. The recitals are hereby incorporated into the body of this Resolution as though fully set forth herein.

**SECTION TWO: DELEGATION OF AUTHORITY.** The Board is hereby authorized to purchase, sell, and lease property, both real and personal, for a period of twelve (12) months from the date hereof.

**SECTION THREE: SEVERABILITY.** If any section, paragraph, or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Resolution.

**SECTION FOUR:** REPEALER. All Township Ordinances, Resolutions, and parts thereof in conflict with or inconsistent with any of the provisions of this Resolution are hereby repealed to the extent they are inconsistent with this Resolution.

**SECTION FIVE: EFFECTIVE DATE**. This Resolution shall be in full force and effect upon its passage and approval.
