Chairperson's Report

The Chairperson also commented on our scholarship program and the need to ensure adequate visibility so that it will be availed by the intended recipients. She also appreciated the impressive number of services - home delivered and other meals served, volunteer hours and other programs.

# Treasurer's Report

Larry Bretz presented the monthly report ending July 2023.

Income - \$12,507.76 Expense - \$6,270.21

Net Income - \$6,237.55 Beginning Fund Balance - \$79,437

Ending Fund Balance - \$85,675

This accounts for 42 % of the fiscal year.

# Director's Report

Social service Manager Diana Gomez presented the report. on behalf of director Megan Conway

• We are looking for more drivers to provide home delivery meal services. Currently, about 40 drivers provide services but we need more.

- Medicare open enrollment season is about to start.
- The Giving Tree starts November 1, and provides an opportunity for donors to help the community.
- PACE conducted their annual onsite audit of our transportation department. Due to COVID, PACE was not able to do the annual audit for the past three years. There were no adverse findings from the audit.
- Social Services team is now accepting applications for the annual adopt-a-senior program. If someone is in need please refer them to the Social services department. Clients receive a care package and an invitation to an annual holiday party in December. In October, the department will also accept applications for the low income home energy assistance program. (LIHEAP). LIHEAP provides credit towards gas and electric bills during cold winter months.
- Home health care continues to grow. Fifteen clients are currently enrolled and receiving visits. We will be celebrating the second anniversary of the Home services program on November 3rd.
- In Nutrition, the Cafe operations continue to exceed pre-pandemic levels. Nutrition manager Perri has sought to increase the program to an eighth route.
