

Hanover Township  
Road and Bridge Tax Levy Ordinance

Ordinance 1221211

An Ordinance levying taxes for all corporate purposes for **HANOVER TOWNSHIP ROADS AND BRIDGES, COOK COUNTY, ILLINOIS**, for the fiscal year beginning **April 1, 2021** and ending **March 31, 2022**.

**BE IT ORDAINED** by the **Board of Trustees of Hanover Township**, Cook County, Illinois, as follows:

**SECTION 1:** Hanover Township does hereby determine and declare that the sum of **ONE MILLION, SIX HUNDRED AND EIGHTY ONE THOUSAND, NINE HUNDRED AND TWENTY ONE (\$1,681,921)** is hereby levied upon all property subject to taxation within the Hanover Township as that property is assessed and equalized for the current year, in order to meet and defray all the necessary expenses and liabilities of the Road and Bridge Fund as required by statute or voted by the people in accordance with the law, for such purposes as: **GENERAL ROAD FUND** for the fiscal year beginning **April 1, 2021** and ending **March 31, 2022**.

**SECTION 2:** That the amounts to be levied for each object and purpose shall be as follows:

**1.1 ADMINISTRATION**

**SECTION 3:** The Hanover Township Board of Trustees certifies to the Cook County Board and Clerk that the amounts levied herein are the amounts necessary to be levied for Hanover Township Road and Bridge purposes. It is hereby directed that the aforesaid sum of **\$1,681,921.00** be raised by taxation in the manner provided by law.

**SECTION 4:** That the Clerk shall make and file with the County Clerk of said County of Cook, on or before the time required by law, a duly certified copy of this Ordinance.

**SECTION 5:** That if any subdivision or sentence of this Ordinance shall for any reason be held invalid or be unconstitutional, such finding shall not affect the validity of the remaining portion of this Ordinance.

**SECTION 6:** That this Ordinance shall be in full force and effect upon its adaption, as provided by law.

**SECTION 7:** That all prior ordinances and resolutions in conflict or inconsistent herewith are expressly repealed only to the extent of such conflict or inconsistency.
