**A RESOLUTION  
TO APPROVE AN INTERGOVERNMENTAL BETWEEN HANOVER TOWNSHIP  
AND THE BARTLETT FIRE PROTECTION DISTRICT**

**BE IT RESOLVED** by the Supervisor and Board of Trustees of Hanover Township, Cook County, Illinois, as follows:

**SECTION ONE: APPROVAL.** The Intergovernmental Agreement (the "Agreement") between Hanover Township (the "Township") and the Bartlett Fire Protection District (the "District"), a copy of which is appended hereto and expressly incorporated herein by this reference, with respect to the provision by the Township of snow removal services for the District's driveways and parking lots at certain District fire stations, as provided more fully therein, is hereby approved.

**SECTION TWO: AUTHORIZATION.** The Township Supervisor and the Township Clerk of Hanover Township are authorized to sign and attest, respectively, the Agreement on behalf of Hanover Township.

**SECTION THREE: SEVERABILITY.** If any section, paragraph, or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Resolution.

**SECTION FOUR: REPEALER.** All prior Ordinances and Resolutions in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

**SECTION FIVE: EFFECTIVE DATE.** This Resolution shall be in full

force and effect upon its passage and approval.
