WHEREAS, the Supervisor and Board of Trustees of Hanover Township (collectively, the "Township Board") desires to provide all persons an opportunity to address public officials at Hanover Township Board and Committee Meetings in accordance with Section 2.06 of the Open Meetings Act5 ILCS 120/2.06; and

WHEREAS, the Township Board deems it necessary and appropriate for the efficient, orderly, and safe administration of Hanover Township Board and Committee Meetings to adopt the "Policy Regarding Rules of Decorum," a copy of which is attached hereto and incorporated as though fully set forth herein by this reference; and

NOW, THEREFORE, BE IT RESOLVED by the Supervisor and Board of Trustees of Hanover Township, Cook County, Illinois, as follows:

SECTION ONE: INCORPORATION OF RECITALS. The recitals and attachments referenced therein are hereby incorporated into the body of this Resolution as though fully set forth herein.

SECTION TWO: ADOPTION. The Policy Regarding Rules of Decorum, a copy of which is attached hereto and incorporated into the body of this Resolution as though fully set forth herein, is hereby adopted and approved.

SECTION THREE: **SEVERABILITY**. If any section, paragraph, or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or

unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Resolution.

SECTION FOUR: REPEALER. All prior Ordinances or Resolutions in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

SECTION FIVE: EFFECTIVE DATE. This Resolution shall be in full force and effect upon its passage and approval.
