WHEREAS, Due to the effects of the coronavirus pandemic, more than 42 million people may experience food insecurity, including a potential 13 million children; and

WHEREAS, Feeding America, a national non-profit, projects that 613,360 — 11.8% — of Cook County residents this year will have lived in households that struggle with food insecurity; and

WHEREAS, Every community in the country is home to families who face hunger, including rural and suburban communities; and

WHEREAS, the Hanover Township Food Pantry is currently experiencing over 600 visits per month from residents in portions of the Cook County communities of Bartlett, Elgin, Hanover Park, Hoffman Estates, Schaumburg, Streamwood and unincorporated neighborhoods; and

WHEREAS, the Hanover Township Food Pantry's client choice model of service ensures residents are able to shop twice a month for a wide selection of fresh fruits, vegetables, goods and other products to ensure no family experiences hunger.

### **Declaring September as Suicide Prevention Month in Hanover Township**

WHEREAS, the Hanover Township Board of Trustees, does hereby find as follows:

WHEREAS, the month of September is hailed by mental health advocates, survivors, and prevention organizations as National Suicide Prevention Month; and

WHEREAS, suicidal attempts and thoughts are a public health issue affecting many Americans and having a significant societal and economic cost for individuals, families, and communities; and

WHEREAS, by drawing attention to the issue of suicide in the United States, this may reduce the stigma surrounding the topic, as well as encourage the pursuit of mental health assistance and support people who have attempted suicide; and

WHEREAS, young adults ages 18 to 25 have the highest rates of suicidal thoughts and attempts of any age group and according to the most recent Centers for Disease Control and Prevention (CDC) statistics, suicide is responsible for nearly 45,000 deaths in the U.S. each year — an average of 123 a day; and

WHEREAS, numerous individuals, professionals and organizations have dedicated their efforts to educating the public about suicide prevention and the availability of treatment; and

WHEREAS, the American Association of Suicidology, Suicide Prevention Lifeline, NAMI (National Alliance on Mental Illness), the Illinois Department of Human Services, and other organizations which assist with suicide prevention invite all residents of Hanover Township to participate in Suicide Prevention Awareness Month.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Hanover Township Board of Trustees, Cook County, Illinois, that the month of September 2021 is Suicide Prevention month in Hanover Township.

SECTION ONE: Addendum No. Four ("Addendum No. 4") to the Building Lease, dated July 1, 2008, as modified by Addendum No. One, Addendum No. Two, and Addendum No. Three thereto, dated July 22, 2008, January 4, 2011, and June 1, 2020, respectively, between the Bartlett Volunteer Fire Association and Hanover Township (the "Township"), a copy of which is appended hereto and expressly incorporated herein by this reference, is hereby approved subject to the Township Attorney's approval.

**SECTION TWO:** The Township Supervisor and the Township Clerk of Hanover Township are authorized to sign and attest, respectively, Addendum No. 4 on behalf of the Township following approval by the Township Attorney.

**SECTION THREE: SEVERABILITY.** The various provisions of this Resolution are to be considered as severable and if any part or portion of this Resolution shall be held invalid by any Court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this Resolution.

**SECTION FOUR: REPEALER.** All prior Ordinances and Resolutions in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.
