Hanover Township Youth and Family Services is pleased to offer you a tutoring program to help your child increase their academic skills. Five certified teachers will provide weekly, one-hour small group tutoring sessions on <u>Tuesday or Thursday evenings</u>, at 5:00, 6:00, or 7:00 PM. Students should be able to read and work independently in a small group for one hour. Tutoring will take place at Streamwood High School, 701 W. Schaumburg Road, Streamwood, IL 60107 (Sabre Center: Door 31).

#### **ELIGIBLITY AND REQUIREMENTS:**

To be eligible, your child must meet the following criteria and a parent or guardian must sign and return this completed form.

- 1. Student must live in Hanover Township (the Cook County portion of Bartlett, Streamwood, Hanover Park, Elgin, Schaumburg, or Hoffman Estates) and must currently be in Grades 2 through 12. Out-of-Township residents, please call (630) 483-5799 for more information.
- 2. A guardian 18 years or older for 2<sup>nd</sup> through 8<sup>th</sup> grade students must remain in the building during the Tutoring Sessions.
- 3. A \$45.00 fee per semester/per student is due when completed form is delivered. Please return your application form (Section A & B) to be guaranteed a slot at the beginning of the semester. Tutoring slots will be filled on a first come first served basis.
- 4. All students must bring his or her own school materials and assignments to Tutoring Sessions or students may bring his or her own grade level workbook to Tutoring Sessions. The workbooks can be found in book stores and Sam's Club.
- 5. Upon completion of tutoring application, and receipt of fee, your child/children will be assigned a tutoring time.
