

Minutes of a Rescheduled Meeting of the Hanover Township Board 250 S. State Route 59, Bartlett, IL Tuesday, April 12, 2016

I. Call to Order/Roll Call

Supervisor McGuire called the meeting to order at 7:00 p.m. Clerk Dolan Baumer called the roll; present were Trustees Benoit, Caramelli, and Essick, and Supervisor McGuire. Trustee Krick was absent.

Other Elected Officials present were Assessor Smogolski and Commissioner Ochoa.

Others present included Administrator James Barr, Welfare Services Director Mary Jo Imperato, Community & Veterans Affairs Director Tom Kuttenburg, Assistant Administrator Suzanne Powers, Management Analyst Sam Hughes, Attorney Mike Airdo, Village of Streamwood Trustee Mike Baumer, and other township residents and visitors.

- II. Supervisor McGuire invited everyone to stand and join in the Pledge of Allegiance.
- III. Town Hall: Supervisor McGuire asked if there was anyone in the audience who had comments to make or questions to ask of the Board. There was no response.
- IV. Reports
  - A. Supervisor McGuire reported that he met with the TOCC Supervisors Division and GA Hearing Board and had a good meeting. He congratulated staff for working to coordinate better between general practitioners and other medical health professionals for better patient care.
  - B. Clerk Dolan Baumer reported that she had an opportunity to talk, during Township Topics Day last week, to Governor Rauner about the success of townships over the 166 years of their existence; she also spoke with Senators Oberwies and Anderson.
  - C. Highway Commissioner Ochoa offered no report.
  - D. Assessor Smogolski offered no report.
  - E. Treasurer: A motion was made by Trustee Essick and seconded by Trustee Caramelli to approve the Treasurer's Report subject to final audit, and followed by a roll call vote. Roll call: Ayes: Trustees Benoit, Essick, and Caramelli, and Supervisor McGuire. Nays: None. Motion carried and the Treasurer's report was adopted subject to final audit.
  - F. Trustee Liaison Committee Reports: Trustee Caramelli reported that the Senior Citizens Services Committee has elected a new Board. Trustee Benoit reported that all funds (\$186,000) have been distributed to area services agencies, primarily to those facing shortfalls due to the state budget impasse.
