MINUTES of the MEETING

September 24, 2019

The meeting was called to order by Chair Kristen Cruthers at 6:30 p.m.

Approval of the Agenda: Ms. Cruthers asked all in favor of approving the agenda to say aye. The motion was approved by unanimous vote.

Presentations: The Board heard requests for midyear funding from Julie Frankino regarding renovating the second bathroom in the Community Integrated Living Apartment Little City runs in Hanover Township, Suzanne Ploger, regarding a new van for Journeys from PADS to Hope and Jerry Skogmo regarding a new program for Medically Assisted Treatment at Renz Addictions Counseling.

Approval of Regular Meeting Minutes of August 27,2019: Ms. Cruthers asked all in favor of approving the regular meeting minutes of the August 27, 2019 to say aye. Ms. Cruthers pointed out an error in the minutes, stating the Finance Committee was actually supposed to meet in December, not February as indicated. Ms. Teachout noted the mistake and corrected it. The motion was approved by unanimous vote.

Approval of July 2019 Financial Statement:. Ms. Teachout noted that the August statement was not included in the Board packet, as the agenda stated as it was not provided in time for the meeting. Ms. Cruthers called for a vote and the Board unanimously approved the Financial Statement for July 2019.

Manager's Report: The Manager's Report was presented and reviewed. Manager Teachout touched on PADS of Elgin's search for a new location.

New Business:

Little City Capital Funding Request: Ms Biesiadecki moved to consider Little City's Capital Funding request in the amount of \$14,021 and Ms. Garvey seconded. Ms Cruthers reminded the Board how much is left in capital funding. Ms. Rahim mentioned that mobility and accessibility are a major issue for the gentlemen living in the CILA home. Ms. Cruthers called for a vote and the motion passed unanimously.

Journey from PADS to Hope Capital Funding Request: Ms Biesiadecki moved to consider the request of \$25,000 for a new van for Journey from PADS to Hope and Ms. Rahim seconded the motion. Ms. Biesiadecki informed the Board that historically, requests for vehicle were not funded because they were secondary to the main priorities of substance abuse treatment, mental health treatment and developmental delay of the Mental Health Board. Ms Cruthers noted her concern was the number of residents served. She noted that 5% of the clients from Journey from PADS to Hope were Township residents and perhaps the Board should reconsider the amount of the van to 5% of the request. Ms. Biesiadecki motioned to amend the original motion from \$25,000 to \$1,500 to reflect the residents served. Mr. Steichmann seconded. The motion passed.
